Licence for the possession and use of rectified spirit including absolute alcohol for industrial, medicinal, scientific [educational & pathological] and other similar purposes.

Licence is hereby granted under & subject to the provisions of the Bombay Prohibition Act, 1949 (Bom. XXV of 1949) and the rules, regulations and orders made there under to **Principal Dr. Ulhas Patil Homeopathic Medical College and Hospital Jalgaon (Kh.)**

Taluka Jalgaon (hereinafter called "the Licensee") on payment of a fees of Rs.310/- in advance vide challan no.54 dated 09-05-2013. Authorizing him to buy, posses and used rectified spirit including absolute alcohol (hereinafter called "spirit") during the period from **date of issue to 31/03/2014** at his premises situated at Homeopathic ,Pharmacy, Hospital, Physiology,Pathalogy ,,Surgery,Obgy, College and Hospital (hereinafter referred to as "the licensed premises") subject to the following conditions namely :

Conditions

1.The licensee shall not use the spirit for any purpose except for **Educational, Homeopathic, Pharmacy,Practical.**

2.(1) The licensee shall not buy spirit except on a requisition countersigned by an officer of the Prohibition & Excise Department duly authorized in that behalf.

[Provided that no such requisition shall be necessary for a licensee who has obtained an order of exemption under Rule 16 B of the Bombay Prohibition Spirits Rules,1951]

(2) The licensee shall not buy spirit in any [~~calendar months / six months~~] subject to fire proof storage limit allowed by municipal or other competitive authorities during the period of the license more than [**48 Lts. (24 Lts.. Rectified Spirit and 24Lts. Absolute Alcohol)** / ~~bottles of 750/500/250 milliliters each~~] in the aggregate.

(3)The licensee shall not use spirit exceeding [~~48 Lts. (24 Lts.. Rectified Spirit and 24Lts. Absolute Alcohol)~~ / ~~bottles of 750/500/250 milliliters each~~] in any ~~calendar months / six months~~ subject to fire proof storage limit allowed by municipal or other competitive authority.

3.The licensee shall not have in his possession more than bulk [**48 Lts. (24 Lts.. Rectified Spirit and 24Lts. Absolute Alcohol)** / ~~bottles of 750/500/250 milliliters each~~] of spirit at any one time.

4. The licensee shall keep all the spirit received by him in a place in the licensed premises approved by the local inspector of Prohibition and Excise under lock and key and all issues of spirit from the said place shall be made in the presence of the licensee or a person duly authorized by him in writing in that behalf.

5. (1) The licensee shall maintain such accounts as may be prescribed by the [the State Government] under the Act. The account shall be kept in a bound book, paged and stamped with the seal of the Collector or the Mamledar or Tahasildar or Mahalkari or any other officer authorized in that behalf by the Collector.

(2) The licensee [other than the one who has obtained an order of exemption under Rule 16 B of the Bombay Rectified Spirit Rules, 1951] , shall keep along with the account book , the requisition and transport passes relating to the spirit received at the licensed premises.

(3)The licensee shall furnish such returns as may be prescribed by the [the State Government] under the Act.

(4)The licensee shall furnish to the Collector such other information relating to the subject matter of this license as the Collector may from time to time require.
